Work Processes and Related Training include, but are not limited to, metal stud framing, various wallboard applications, acoustical ceilings, doors & door hardware, safety and clean-up, application of fire-proofing and shock-absorbing materials to ceilings and walls of buildings.

Veterans who have GI Benefits may use them in this program. Under certain circumstances veterans may be granted direct entry to the program.

Applications for the Exterior -Interior Specialist program are accepted on continuous basis at **PNCI.org**. Please go to our website, click on the “**Careers**” tab, select “**Apprenticeship**” and follow instructions to fill out application *on-line*. In order to complete the application process, you will be asked to choose a mandatory **Pre-hire** class. This class is intended to provide applicants with orientation about the Trade and the Apprenticeship Program requirements. If there is no Pre-hire class scheduled in your area, you may choose to attend a Pre-hire class in another area or wait until a class is scheduled in your area. Pre-hire classes are posted every 30 days.

Minimum qualifications for applicants are: Seventeen (17) years of age and have a high school diploma, GED, or equivalent OR Eighteen (18) years of age.

Selection Process will be through “ranked interview” of qualified applicants. All applicants will be mailed the results of the ranking.

Whom may apply:

Only the individual seeking admission to the program may apply.
