Geographical Area Covered: All of State of Oregon. Clark, Cowlitz, Klickitat, Skamania and Wahkiakum counties and that portion of Pacific County south of a straight line made by extending the north boundry of Wahkiakum County west to Willapa Bay to the Pacific Ocean and, thence, north through the natural waterway to the Pacific Ocean to include the entire peninsula west of Willapa Bay in the State of Washington under the terms of the reciprocal agreement.

Please Note: Monthly, all applications will be ranked and placed on the Ranked List of Eligibles.

The occupation of **Piledriver** will be taught under Standards administered by the **Oregon-SW Washington Carpenters Joint Apprenticeship Training Committee, MA # 1057**.

The Apprentice in the **Piledriver** Apprenticeship Program will develop skills, knowledge, and experience in many areas. Work Processes and Related Training include, but are not limited to, tools and materials, transit and level, maintenance and care of outboard motors, pumps and light plants. Framework for foundations and footings, concrete form construction, bridge construction and basic timber work. Oxygen-acetylene cutting, welding and arc welding. Pile driving equipment, coffer dams, sheet piling, driving of piles and drilling of piles. Rigging and signaling. Diving and tending (optional). Travel **may be expected** throughout the States of Oregon, Washington and Montana. The Standards for this apprentice program are available at the Pacific Northwest Carpenters Institute.

Veterans who have GI Benefits may use them in this program. Under certain circumstances veterans may be granted direct entry to the program.

Minimum qualifications for applicants are: Seventeen (17) years of age and have a high school diploma, GED, or equivalent OR Eighteen (18) years of age.

Selection Process will be through “ranked interview” of qualified applicants. All applicants will be mailed the results of the ranking.

Who may apply: Only the individual seeking admission to the program may apply.
